7 A bill amending Title II of the Oklahoma State University Student Government Association
8 Bylaws; providing for forwarding; and providing for an effective date.

10 BE IT ENACTED BY THE STUDENTS OF OKLAHOMA STATE UNIVERSITY THAT:

12 **Section 1: AMENDATORY:**

13 Title II, Section 18.5.2 shall be amended to read as follows:

14
15 18.5 The Speaker's Board shall strive to choose a minimum of three speakers to be scheduled
16 throughout the academic year. The speaker shall have a broad appeal to the students of OSU. A
17 balance of subjects shall be maintained. Speakers who discuss more serious and educational
18 topics will be given priority.

19 18.5.1 Speakers proposed by individual students or campus organizations shall be given
20 the same consideration as speakers proposed by committee members.

21 18.5.2 The Board will be responsible for providing a diversity speaker ~~during the spring~~
22 semester.
